BY ENRIQUE LUIS RUIZ AND JIMMY LEE MASSEY, WHO ACTING JOINTLY AND IN



I, J R JENCKS, being first duly sworn and upon oath, depose and state as follows:

I am a Police Lieutenant employed by the Bethany Police Department, City of Bethany, County of Oklahoma County, assigned to the Patrol Division.

That on October 13, 2011 the Bethany Police responded to a call of suspicious odor in the 7100 blk of NW 23rd in the City of Bethany. Upon arrival Officers found that a human female body had been dumped in a field a short distance from the Homeland grocery store located there. The body had been dismembered and placed in a bag. During the investigation the identity of the body was confirmed by the Medical Examiners office from tatoos and dental records as that of 19 year old Carina Brianne Saunders. Saunders had been reported as a missing person from Oklahoma City in early October 2011.

During the course of the investigation the name of "Country" was developed as a possible suspect. The name Country was found to be the nickname of a subject identified as Jimmy Lee MASSEY, date of birth 07/20/78. At the same time that the Saunders homicide investigation was going on there was corresponding task force investigation going on which linked Jimmy MASSEY to a group of other individuals that were moving very large amounts of Methamphetamine. As a result of that investigation Jimmy Lee MASSEY was taken into custody on trafficking and conspiracy charges on November 4, 2011. MASSEY was transported to the Bethany Police Department and was interviewed. After waiving his Miranda rights and while video recorded, MASSEY, gave a statement admitting that he was present when Carina Saunders was murdered and viewed it.

Later during the investigation a witness was found identified as [REDACTED] who said that [REDACTED] was at the location where the homicide occurred just prior to it occurring. [REDACTED] said that the location was a two story house located at 3500 S Harvey. [REDACTED] said that [REDACTED] left the residence shortly after Carina Saunders arrived with a second girl. [REDACTED] said that Jimmy MASSEY, who also knew as "Country" was at the residence when [REDACTED] left. The date of this incident was determined as October 11, 2011 by the girl that arrived with Saunders at the location, [REDACTED]. [REDACTED] later witnessed the murder of Saunders and jumped out a window to escape.

While Jimmy MASSEY was in Oklahoma County Jail on the drug charges he communicated with two different detainees. One detainee is identified here as J.L. Massey told J.L. that, he was involved in the homicide and described the fact that they cut the girls arms and legs off. That information has not been made public and only those persons at the autopsy and involved in the investigation have that knowledge.

To the second detainee Jimmy MASSEY actually gave hand written statements in the form of passed notes describing what parts of the body were dismembered and perhaps more importantly, how the body was wrapped prior to disposal. Those

same notes have been compared to known samples of Jimmy Massey's hand writing and appear to be from the same person on initial examination. Those same notes are in BPD Evidence. MASSEY's description of the material used to wrap the body was very specific to the actual material the body was wrapped in. Again, nobody has that information except those directly involved in the autopsy, investigation, or the homicide.

Based on my investigation I believe the DEFENDANT to be guilty of:
1) Murder First Degree (Carina Brianna Saunders) O.S. 21 701.7.A.

I, J R JENCKS, being first duly sworn and upon oath, depose and state as follows:

I am a Police Officer employed by the Bethany Police Department, City of Bethany, County of Oklahoma County, assigned to the Investigations Division.

On October 13, 2011 Bethany Police responded to a report of a bad odor and found a duffel bag that contained what appeared to be a decomposing and dismembered human body located near a field in the 7100 blk of NW 23rd in the City of Bethany, County of Oklahoma, State of Oklahoma. That body was later identified by the Oklahoma Medical Examiner as that of Carina Brianne Saunders, date of birth 07/17/92. The Medical Examiner ruled it as a Violent Death and Homicide. During the investigation there were dozens of persons interviewed. One of those subjects is [REDACTED] advised that he was riding in a pick-up with Luis RUIZ in February or March of 2012. During that ride RUIZ stated that he had been the one that planned the entire incident which resulted in the death of Carina Saunders. Another person contacted was [REDACTED] said that she had been the girlfriend of Luis RUIZ during the month of October. [REDACTED] said that while she was with RUIZ on two occasions they had to "baby sit" a girl that she later found out was Carina Saunders. [REDACTED] said that RUIZ told [REDACTED] that Saunders was going be "dealt with." Later in January or February of 2012 RUIZ told [REDACTED] that he had planned the incident which resulted in the death of Carina Saunders.

Investigators later talked with [REDACTED]. [REDACTED] advised that on October 11, 2011, she went with Carina Saunders to a house on south Harvey in the City of Oklahoma City, in the County of Oklahoma. While at that house she witnessed RUIZ physically beat Carina Saunders and then tie her up. That he drug her to an upstairs room and tied her to a small table. That he used rope and thin twine. That he then cut off her left foot and then tried to cut off her right foot when the saw broke. That injuries to body found during autopsy match injuries described by [REDACTED] including ligature marks across the shins.

Investigators later talked with [REDACTED] said that she had been at the house on south Harvey when [REDACTED] and Carina Saunders arrived but left soon after. [REDACTED] said that she had been told by a third party that there was a video of the homicide on a phone and that phone belongs to Luis RUIZ. [REDACTED] said that on the first or second Sunday after Mother's Day 2012, (May 13), she was at the Bel-Aire hotel in the same room with Luis RUIZ. That when RUIZ went to the bathroom she looked at his phone and viewed the video of the Homicide. [REDACTED] said she watched for a few seconds until Saunders began to scream. [REDACTED] said she recognized Ruis LUIZ as the person in the video cutting off the foot of Saunders.

Based on my investigation I believe the DEFENDANT to be guilty of and request

that a warrant for his arrest be granted for the crime of 1) Homicide First Degree T. 21 O.S. 701.7.


